

I attest that I, Lloyd S. Klee, am employed by Alternative Adjustors, LLC as President and co-owner and have been with Alternative Adjustors LLC since April 1, 1998. I was previously employed by Crawford & Company. Alternative Adjustors LLC and Crawford & Company are insurance investigators and insurance adjusters. To Whom It May Concern:


